Dear Carl:

Because of the imminence of the Shoreham Nuclear Power Plant's fuel load date, the Long Island Lighting Company has requested the TDI Diesel Generator Owners Group utilities to take over the technical direction of the Owners Group in order to release key LILCO personnel for support of the Shoreham station during its fuel load and startup testing phases. Duke Power Company will be assuming the technical direction of the Owners Group on May 3, 1984 and a transition has already begun. The Owners Group will remain headquartered at the Shoreham site and Duke personnel will be in permanent residence at Shoreham beginning April 16, 1984.
