

EXPLANATION OF CHANGE

- 1) IRTS START UP - The current start date for this activity is now 19 working days earlier than last reported. This is attributed to the partial recovery of last weeks schedule slip in the design, fabrication and testing of the hydraulic arms required for column servicing. It should be recognized however that the current October 11, 1991 date for adding caustic to the tanks is 4 days later than WVNS's committed date for start up, October 7, 1991. This delay continues to be caused by the hydraulic arms.
