Page 76, line 16

Change "define and risk" to "define the risk."

Page 84, line 5

Insert "[Cordaro, Weismantle]" before the beginning of the answer.

Page 90, line 6

Change "[Cordaro, Weismantle]" to "[Clawson, Cordaro, Weismantle]."

Page 100, line 20

Change "[Clawson, Cordaro, Weismantle]" to "[Clawson, Cordaro, Robinson, Weismantle]."

Page 101, line 7

Page 103, lines 5-9
