LICENSEE'S REQUEST FOR DELAY IN  
SCHEDULED PREHEARING CONFERENCE

The Appeal Board in ALAB-772 reopened and remanded this proceeding to the Licensing Board for further hearing. Unbeknownst to Licensee, by Order dated June 11, 1984, the Licensing Board scheduled a prehearing conference on the remanded issues for June 28, 1984; Licensee received the Order on June 12, 1984. On June 11, 1984, Licensee filed with the Commission notice of intention to petition for review of ALAB-772 and sought until June 28, 1984 to file the petition. Also, on June 11, 1984, Licensee filed with the Appeal Board a request for stay of ALAB-772 in so far as it reopened and remanded matters, pending the outcome of appeals from ALAB-772. Under these circumstances, Licensee requests that the Licensing Board delay

scheduling a prehearing conference on the issues remanded by ALAB-772 until Licensee's request for stay has been decided. Licensee counsel sought the views of other parties on this request.
