On March 11, 2020, the U.S. Nuclear Regulatory Commission (NRC) completed a security inspection of the Physical Protection Program for the La Crosse Boiling Water Reactor (LACBWR) (Decommissioning), Independent Spent Fuel Storage Installation (ISFSI) located near Genoa, Wisconsin. The NRC inspectors discussed the results of this inspection with Mr. Lane Peters and members of his staff. The results of this inspection are documented in the enclosed report.

One Severity Level IV violation of NRC requirements is documented in this report. Because of the very low security significance and because the issue was entered into your corrective action program, the NRC is treating the issue as a Non-Cited Violation in accordance with Section 2.3.2 of the NRC's Enforcement Policy.

If you contest the violation or significance or severity of the violation documented in this inspection report, you should provide a response within 30 days of the date of this inspection report, with the basis for your denial, to the U.S. Nuclear Regulatory Commission, ATTN: Document Control Desk, Washington, DC 20555-0001; with copies to the Regional Administrator, Region III, and the Director, Office of Enforcement.
