Subject: Cancellation of Radiation Effects Reactor License R-86,
Docket No. 50-172

Gentlemen:

In accordance with the Decommissioning Plan for the Radiation Effects Reactor, approved for implementation by your letter of May 27, 1971, all reactor fuel and all reactor control rod drives have been removed from the Dawsonville site. The irradiated fuel was shipped to Savannah River and the unirradiated fuel was shipped to Oak Ridge. The control rod drives were disposed of as radioactive waste by Chem Nuclear Inc., under Contract to Lockheed.

It is therefore requested that Radiation Effects Reactor License R-86 be cancelled. At the time of cancellation, all concerned areas of the facility will be placed under a State of Georgia By-Product Materials License, which is currently being prepared.

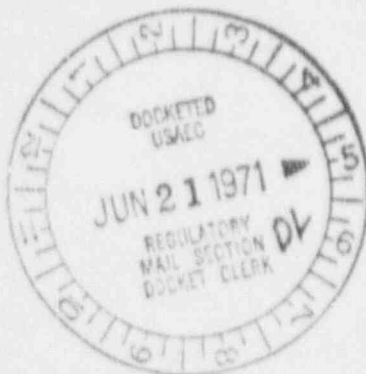
Please request that the Division of Compliance conduct a final inspection of the facility at their earliest convenience.
