This draft of the document is being submitted in accordance with our summary statement in response to Mechanical Engineering Branch Question 210.34 and Draft SER Open Item 42 on NF component supports. This response was discussed in the April 1984 audit and it was documented by Letter 2NRC-4-052 from E. J. Woolever to G. W. Knighton, dated May 7, 1984. This draft of the ASME Code Baseline Document is not presently being submitted for NRC review or comment but is being submitted for information as a response to the MEB question.

Please make arrangements for a July 26, 1984, meeting in Bethesda so that this document in its final, approved form can be formally presented to the staff. DLC will be prepared to answer NRC questions at that time. It is specifically requested that Mr. G. Walton, NRC Sr. Resident Inspector, be in attendance at this meeting.


