PALISADES PLANT - SUPPLEMENTAL RESPONSE TO IE INSPECTION REPORT 84-05

IE Inspection Report 84-05 transmitted seven items of noncompliance which Consumers Power Company responded to by letter dated May 21, 1984. In our response, we stated that the corrective actions taken to avoid further non-compliance concerning four of the items (1, 2, 3 and 5) are contained in LER 84-001. Additionally, we stated that we are in full compliance with respect to those four items at this time. In a telephone conversation on May 29, 1984, a member of the Region III staff requested we specify which sections of the LER pertained to each item of noncompliance and submit a schedule for completion of the corrective actions. The requested information is hereby provided.
