

Submittal of Revised Emergency Plan


Attached is Revision 0 to the Millstone Site, Unit No. 3 inclusive Emergency Plan. This is being forwarded per the commitment made in Reference (1) and replaces the draft Emergency Plan submitted in October of 1982 along with the OL Application. The attached plan is still considered preliminary in nature. As such it will again be updated and submitted on or before January 1, 1985 to among other things include a finalized version of the EAL table which is still evolving along with plant procedures. It should be noted that with the submittal of this document two (2) Millstone Site Emergency Plans will exist. However, the Millstone Unit No. 3 inclusive plan will not become the effective site plan until required to support the November 1985 fuel load date. At that time it will reflect the most recent revisions to the Millstone Units 1 and 2 Site Emergency Plan as well as any other required revisions. We view this submittal sufficient to make Draft SER open item No. 172 contained in Section 13.3a confirmatory.


