The Revision to Temporary Addendum One and Temporary Addendum Two are being
submitted in accordance with section 10.4 of the Physical Security Plan. None of the changes
described in the Temporary Addenda represent a lessening of security effectiveness.

These Temporary Addenda describe measures taken during construction activities associated
with the vehicle barrier upgrade project. South Texas Project will notify the Nuclear
Regulatory Commission when the temporary changes described in the Addenda have been
returned to the requirements of our Physical Security Plan, Revision 2A. The notification will
serve to rescind the respective Physical Security Plan Addendum.


