Gentlemen:

By letter dated April 4, 1995 (OCAN049505), Entergy Operations extended the submittal dates for the Arkansas Nuclear One (ANO) IPEEE and unresolved safety issue (USI) A-46 summary reports based upon an understanding that Generic Letter (GL) 88-20 would be supplemented. On September 8, 1995 (OCNA099504), the Staff issued Supplement 5 to GL 88-20 which requested licensees who voluntarily choose to perform seismic IPEEEs using the modified procedures described in supplement to submit a 60 day response.

ANO-2 and ANO-1 are designated as focused-scope and full-scope seismic review plants, respectively. Entergy Operations intends to perform the seismic IPEEEs using the modified procedures described in items (2) and (3) of the "Modified Scope of Examination" section of Supplement 5 to GL 88-20 for ANO-2 and ANO-1, respectively.

In order to allow sufficient time to complete this review, Entergy Operations intends to submit the IPEEE/USI A-46 summary reports by March 31, 1996 for both of the ANO units. Should you have any questions, please contact me.

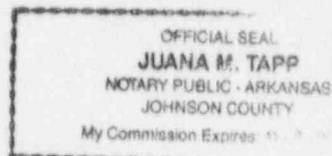
