Pursuant to the requirements of 10 CFR 50.54 (p), Union Electric furnishes herewith six copies of changes to the Callaway Plant Physical Security Plan effected after August 11, 1984. It is our contention that the attached changes do not decrease the safeguards effectiveness of the plan.

The proposed changes include the availability of additional sets of vital area keys as discussed in References 1 and 2. With the exception of changes to Tables 4.6-1 and 5.4-1, the attached changes shall be incorporated into Revision 5 of the Callaway Plant Physical Security Plan at a later date. Changes to Tables 4.6-1 and 5.4-1 are included in Revision 4 of the newly reprinted Callaway Plant Physical Security Plan which will be sent to holders of controlled copies by October 31, 1984.
