Gentlemen:

During the week of July 16-20, 1984, the OSTR staff completed all of the required initial training for our facility personnel and support agency personnel relative to implementation of the new OSTR Emergency Response Plan and implementing procedures. In addition, an action drill was successfully performed on July 20, 1984. As a result of the training and the drill, a number of minor changes to the plan were made. None of the changes decrease the effectiveness of the plan. As required by 10 CFR 50.54 (q), the changes are hereby reported, and are summarized in Attachment A to this report for your information. The changes listed in Attachment A have been reviewed and approved by the OSTR Reactor Operations Committee.


