Gentlemen:

The letter of October 18, 1984 from Joseph Gallo informed you that certain diary notes prepared by Mr. J. J. Lipinsky would be produced today, pursuant to the subpoenas issued to Oliver B. Cannon & Son, Inc., after counsel had time to review them and determine the extent to which any privilege would be asserted. We are hereby producing and enclosing those diary notes, with the exception of the following notes as to which privilege is asserted. Mr. Lipinsky's notes for November 30, 1984, December 1, 1984, December 8, 1984, and a portion of his notes for December 8, 1984 are being withheld. Counsel for Oliver B. Cannon & Son, Inc. is asserting privilege on behalf of Mr. Lipinsky based on an attorney/client relationship that exists with respect to Mr. Lipinsky and Messrs. Reynolds and Watkins.

In addition we are producing and enclosing three documents that were inadvertently omitted from the materials produced yesterday. These consist of a desk memo of Robert B. Roth dated December 14, 1983, a memorandum of Ralph A. Trallo dated October 8, 1982 attaching a Three Mile Island Damage Report, and a May 23, 1984 letter from Richard L. Bangart attaching a Region IV Interim Report on Protective Coatings prepared by Brookhaven National Laboratory.


