Enclosed for filing with the Commission is Amendment No. 68 to the License Application of Philadelphia Electric Company in the above captioned matter. This Amendment makes changes to the Final Safety Analysis Report as a result of discussions with several Branches of the NRC Staff and to accurately reflect the Limerick design and makes changes to the Design Assessment Report for consistency with the FSAR.

The filing consists of three originals and nineteen copies of Amendment No. 68 to the License Application, fifty copies of Revision 34 to the Final Safety Analysis Report, 40 copies of Revision 9 to the Design Assessment Report (Volumes 1 and 2) and 5 copies of Revision 9 to the Design Assessment Report (Volume 3).

As indicated in Amendment 68, Revision 9 to volume 3 of the Design Assessment Report contains proprietary and confidential information. Accordingly, it is being requested that the Revision to Volume 3 be withheld from public disclosure in accordance with Section 2.790 of the Commission's regulations.


