Subject: NRC IE Bulletin 83-06

This letter provides Detroit Edison's final response to Reference (2). Detroit Edison in response to IE Bulletin 83-06, conducted an extensive investigation which revealed that no Tube-Line products were received for use in safety related systems at Fermi 2.

Bulletin 83-06 did not list Fermi 2 as a recipient of Tube-Line products. In cases where the eventual recipient is not listed, it was assumed that Fermi 2 could have received the products. A search was made of purchase order and receiving inspection files of site organizations performing safety related work who could have purchased or received Tube-Line products during the period in question. No Tube-Line products were found in the documentation reviewed.






