In response to a recent staff request relative to the McGuire NUREG-0737 Supplement 1 response on Control Room Review, the following information is provided.


By letter dated May 29, 1984 on the Catawba Nuclear Station dockets 50-413 and 50-414, Duke Power provided a response to those Task Analysis clarification comments contained in Mr. H. B. Clayton's memo of April 5, 1984 to Mr. D. L. Ziemann. This response is also applicable to McGuire.

By letter dated April 9, 1984 on the Catawba dockets, Duke provided a response to the preliminary draft SER for the Catawba detailed Control Room design review transmitted by a NRC letter dated March 9, 1984. Item 5 contained therein responded to the request to discuss Control Room modification and additions made or planned at Catawba as a result of other post-TMI actions. For McGuire, Task Analyses for Inadequate Core Cooling and for an ATWS event were conducted by the Task Analysis Team during the Control Room Review using Westinghouse Emergency Response Guidelines FR-C.1 and ECA-1. HEDs identified during the Task Analysis activities were assessed by the Review Team and required HED corrective actions are described in the Supplement to Final Report, McGuire Nuclear Station, Unit 1 & 2 dated February 16, 1984.

In addition, Duke Power performed a review in response to Generic letter 83-23, dated July 8, 1983, concerning the Salem ATWS Event. No additional McGuire Control Room changes were identified as a result of this review.
