Gentlemen:

By letter dated July 13, 1984 (postmarked July 31 and received by Applicant on August 2, 1984), Mr. Sugarman purports to update his earlier letters of May 23 and July 5, 1984 to the Licensing Board and Appeal Board.

In its Memorandum and Order dated April 19, 1984 denying Del-Aware's late contentions, the Board held that it lacks jurisdiction over the supplementary cooling water issues raised by Del-Aware (slip op. at 3). Further, we note that in a Memorandum dated July 11, 1984, the Appeal Board ruled that it "will take no action with regard to any of the 'requests' in counsel's July 5, 1984, letter or in any future letters. Moreover, other parties need not reply to such informal submissions."


