(e) the number of inspectors of the element who were reinspected. Separately for each inspector and element reinspected, provide:

(i) the number of reinspections that conform with initial inspections and

(ii) the total number of reinspections performed.

(The tabulation for (e) should provide the same type of information provided in Table B-5 of the Reinspection Program disaggregated by "inspection element" rather than "attribute".)



(b) the total number of reinspections performed.
