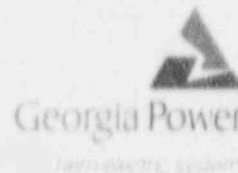

CHANGE IN DESIGNATION OF FINGERPRINT COORDINATOR

Gentlemen:

Effective January 2, 1992, Georgia Power Company will change the designation of its coordinator for processing of fingerprint information pursuant to 10CFR73.57 to Mr. Lyle Mitchell, Manager of Corporate Security - Southern Nuclear Operating Company, Inc. (Southern Nuclear). This change is being effected to provide a central repository for fingerprints for the Southern Company nuclear plants. Previously, Alabama Power Company made the change for Plant Farley in their letters dated November 13, 1989 and January 3, 1991. Mr. Mitchell's address is as provided below:

Southern Nuclear is a service company providing a wide range of services to Georgia Power Company which include security, fuel procurement, engineering, administrative, and technical support. Services associated with nuclear generation are provided under the general supervision of the Senior Vice President and Executive Vice President of Georgia Power Company, whose offices are also located at 40 Inverness Center Parkway. As a matter of information, Southern Nuclear is in the process of assuming operating responsibility from Alabama Power Company for Plant Farley.

As coordinator, Mr. Mitchell will be responsible for the review and evaluation of Criminal History Check results. The final disposition will remain the responsibility of the Georgia Power Company's Senior Vice President or Executive Vice President, or their designees.

As Manager of Corporate Security, Mr. Mitchell will be able to limit the dissemination of criminal history information effectively, confining it solely for the purposes permitted by statute in connection with nuclear plant access authorization. Mr. Mitchell is fully cognizant of, and will comply with, Paragraph 606 of Public Law 99-399 (42 U.S.C. Paragraph 2169) and applicable regulations (10CFR73.57) to limit the dissemination of such information and to ensure that such information is used solely for the purpose of determining whether an individual shall be permitted unescorted access to the facility of a licensee or applicant or shall be permitted access to safeguards information.



Regardless of the individuals submitting the card(s) on behalf of Georgia Power Company, Mr. Mitchell is the only individual authorized to receive the results of the criminal history searches. He should be the individual contacted by your representative on any administrative matters associated with 10CFR73.57 activity or on any return of fingerprint cards which cannot be processed.

This notification supersedes all previous notifications on this matter. If there are any other changes required to our designated list, we will notify you in writing.

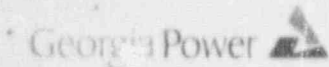
