The purpose of this letter to provide the sixty-day response to Generic Letter 88-20, Supplement 5 (Reference 1) and to notify the NRC that Duquesne Light Company intends to perform the Beaver Valley Power Station, Unit No. 2, seismic IPEEE using the modified procedures described in Generic Letter 88-20, Supplement 5.

It has been determined that, by electing to use the modified procedures of Supplement 5, the schedule previously committed to for the Beaver Valley Power Station Unit No. 2 IPEEE need not be revised.

Please be advised that the previous choice to use the reduced scope for the seismic evaluation of relays for the Beaver Valley Power Station Unit No. 2 IPEEE, as described in Reference 2, is rescinded by the choice stated herein to use the modified procedures of Supplement 5.




