A meeting was held at Region III between Commonwealth Edison personnel and Messrs. R. Walker, W. Gulderson, C. Williams, et. al. of your staff. During this meeting, Commonwealth Edison proposed an alternative method to satisfy the NRC requirement contained in item 2.C of reference (a). This letter documents our commitment made during that meeting.

1. LaSalle County Station will incorporate into administrative procedures cautions stating the color of control indicating lights have been changed in the field to implement the "green board" concept and may not match the colors shown on drawings.
2. Administrative procedures governing modifications, work requests, and post maintenance testing will be revised to include the cautions necessary to prevent inadvertent compromise of green board concept due possible differences in control light color arrangements shown on drawings.
3. The green board concept and the resulting deviation from control light color arrangements shown on drawings will be included in an annual operator training module and in the station retraining program.
4. The above commitments are applicable to LaSalle County Station and to any other CECO Nuclear Generating Station which elects to implement the green board concept without revision of appropriate drawing control light color arrangements.




