Crouse Hinds letter dated February 10, 1987, (reply to
Bechtel letter V-4302 dated January 28, 1987) indicates that
Chico-A4 compound has used the same two non-organic
ingredients for the past fifteen years and there have been
no changes which could affect the mechanical properties of
the compound. A copy of the Crouse Hinds letter is
enclosed.

In view of the above, the environmental qualification
performed on Chico-A4 sealing compound can be applied to the
compound procured against APCO Purchase Order No. QP-1220.


