have been made to the plan to address the issues identified in the  
enclosure of Reference 3.

A revision summary of the changes made by Revision 18 to the Fermi 2

changed by Revision 18 are being submitted. All changes to the text  
are highlighted (shaded). The changes made under this revision do not  
decrease the effectiveness of the Fermi 2 Physical Security Plan.


