Subject: 10CFR50.59 Annual Report

Gentlemen:

Enclosed please find the report of facility and procedure changes made at Seabrook Station pursuant to 10CFR50.59 during the final three quarters of 1991. The report for the first quarter of 1991 was submitted by Reference (b).

Based upon a 1986 commitment, NHY had been submitting the 10CFR50.59 Report on a quarterly basis. In Reference (c), NHY requested a return to an annual submittal frequency for this report. In Reference (d), the NRC concurred with this request; and specified a submittal date for this report of March 31st.

New Hampshire Yankee has determined that the reporting requirements of 10CFR50.59(b)(2) and 10CFR50.71(e) can be more efficiently met by combining the annual 10CFR50.59 Report with the annual revision to the Updated FSAR (UFSAR). Revision 1 to the UFSAR is scheduled to be submitted by May 26, 1991, and will bring the UFSAR up to date as of March 15, 1992. In order to synchronize the annual 10CFR50.59 Report with the UFSAR revisions, the May 1992 submittal forwarding Revision 1 to the UFSAR will include a Supplemental 10CFR 50.59 Report covering the period January 1, 1992 to March 15, 1992. New Hampshire Yankee proposes that future submittals forwarding the annual UFSAR revision will include the 10CFR50.59 Report for the same period.
