Summary of Changes

Revisions to EPIP-OSC-15, Communicator Actions, include: deleting the positions of Technical Support Center (TSC) and Emergency Operations Facility (EOF) Communicators and replacing them with the TSC Emergency Plan Specialist and EOF Emergency Response Coordinator; revising the instructions for providing dose assessment data to the TSC and the EOF; deleting 24-hour staffing instructions; and implementing county notification for all classifications. Please note that ***the changes to EPIP-OSC-15 do contain proprietary information which may not be released to the Public Document Room.*** (Proprietary information includes personnel names, company phone numbers and any information which could impede emergency response.) These issues may only be used for internal NRC copies of the FCS EPIP manuals. A censored version of this procedure has been provided for the Public Document Room.

Procedure EPIP-EOF-6, Dose Assessment, was completely rewritten to delete manual dose assessment methods, add new checklists for each facility, revise the computer assessment process, and replace the EAGLE FAX process with a manual process.


Procedure EPIP-RR-22, Protective Measures Coordinator/Manager Actions, was rewritten to combine the TSC and EOF Protective Measures procedures, address user comments, improve the overall procedure format and detail the process for providing updates to the states/counties.

Procedure EPIP-RR-25, TSC/EOF Dose Assessment Coordinator Actions, was rewritten to combine the TSC and EOF Dose Assessment Coordinator procedures, improve overall format, address user comments and add the comparison process for the field team and dose assessment data.

Various Emergency Plan forms were deleted/revised as a result of their governing procedures being revised/superseded.


