Supplement to License Amendment Request Dated July 17, 1995  
Radiological Effluent Technical Specifications Conformance  
To Standard Technical Specifications and Generic Letter 89-01

Pursuant to discussions with your staff regarding the subject license amendment request, this supplement proposes changes as presented in Attachments 1 and 2 to this letter. Attachment 1 contains current Prairie Island Technical Specification pages marked up to implement the proposed modifications to this license amendment request. Attachment 2 contains Technical Specification pages revised to their final form to reflect the proposed changes. Supplemental information in support of these changes follows.

Pages 2 and 8 of Exhibit A of the subject LAR indicated that the Prairie Island Plant will continue to use Appendix B to old 10CFR Part 20. That discussion is clarified in that the Prairie Island Plant's instantaneous release rate limits will continue to be the values in the old 10CFR Part 20 Appendix B in accordance with the guidance provided in the June 30, 1993 letter from Thomas E. Murley, NRC, to Thomas E. Tipton, Nuclear Management and Resources Council. Accordingly, the references

in proposed Specifications 6.5.E.1.b and 6.5.H.3, pages TS.6.5-5 and TS.6.5-7, respectively, have been changed to "10CFR20.1302."

As proposed in the July 17, 1995 submittal, Technical Specification 6.5.B.1.a Item (4), page TS.6.5-2, will not be used alone but rather will always be used in addition to Item (1), (2), or (3). Thus Item (4) has been deleted from the Technical Specifications proposed in Attachments 1 and 2 to this letter. Since paragraph 6.5.B.1.b referenced 6.5.B.1.a Item (4), it has been revised to appropriately incorporate the referenced wording from Item (4). This change improves conformance of the proposed Prairie Island Technical Specifications to NUREG-1431, Standard Technical Specifications.


From discussions with the NRC staff, it is our understanding that Technical Specification 6.5.H Paragraphs 4, 8, and 9, as proposed in the July 17, 1995 submittal, would be interpreted to reduce the allowable plant releases below the regulatory and current Prairie Island Technical Specification limits. Accordingly, "the site" in each of these paragraphs is revised to "each unit". This change also improves conformance of the proposed Prairie Island Technical Specifications to NUREG-1431, Standard Technical Specifications.

Specification 6.7.C.1, Annual Radiological Environmental Monitoring Report, has been revised to retain existing paragraphs (c) and (d) on page TS.6.7-6. This change improves conformance of the proposed Prairie Island Technical Specifications to NUREG-1431, Standard Technical Specifications. This change also introduces some changes in the specification pagination and concomitant changes to the Table of Contents page TS-ix are provided.

A revised Safety Evaluation, Significant Hazards Determination and Environmental Assessment have not been submitted with the changes proposed by this letter since these evaluations, as originally presented in the July 17, 1995 submittal, continue to bound the proposed license amendment as modified by this supplement.

Recently issued Amendments 120 and 121 do not have an impact on the subject license amendment request, this supplement or the previous supplement dated October 16, 1995.
