I certify, pursuant to 10 CFR 73.56(a)(1), that the access authorization program required by 10 CFR 73.56 has been incorporated into the PVNGS Security Plan and has been implemented. All elements of Regulatory Guide 5.66 have been implemented to satisfy the requirements of 10 CFR 73.56.

APS has determined that the original of the Security Plan, and the replacement pages, contain Safeguards Information and are subject to the controls of 10 CFR 73.21. These pages, so designated, are to be withheld from public disclosure in accordance with the provisions of 10 CFR 2.790(d) and should not be placed in the Public Document Room.


