MODIFICATION TO TECHNICAL SPECIFICATION CHANGE REQUEST NO. 79  
FIRE PROTECTION MODIFICATIONS  
POINT BEACH NUCLEAR PLANT, UNITS 1 AND 2

Together with a letter dated April 13, 1984, Wisconsin Electric Power Company, licensee for the Point Beach Nuclear Plant, submitted a license amendments application to incorporate revisions to those plant Technical Specifications addressing fire protection and detection systems. The April 13 letter was a modification to the Technical Specifications proposed with our letter dated April 19, 1983.

Included with the proposed Technical Specification pages enclosed with our April 13 letter was Table 15.3.14-1, "Safe Shutdown Area Fire Protection". Attached we have provided a revision to that proposed table. The purpose of this revision is to include the water sprinkler system fire protection which is being added by plant modification to portions of the eight-foot elevation of the auxiliary building north and south. It is requested that this revised table be reviewed and considered together with our previously proposed Technical Specifications in this matter.

As discussed in the April 13 letter, some of the fire protection systems addressed by the proposed Technical Specifications are not yet operable. The water sprinkler system in the auxiliary building north and south is presently being installed (or scheduled for installation) and, thus, we would request you notify us prior to issuance of these amendments so that we may establish a schedule for the effective date of the specifications.


