Attached hereto is an application for amendment to Construction Permits No CPPR-81 and CPPR-82 for Units 1 and 2 of the Midland facility. The application requests an extension of the construction completion dates for Unit 1 from December 1, 1984 to December 1, 1989 and for Unit 2 from July 1, 1984 to July 1, 1989. This request supersedes our previous application, dated May 24, 1984, for an extension to Construction Permit No CPPR-82.
