
Dear Mr. Denton:

As required by 10CFR50.54(q), South Carolina Electric and Gas Company (SCE&G), acting for itself and as agent for South Carolina Public Service Authority, submits two (2) copies of Revision 13 to the Radiation Emergency Plan.

Revision 13 reflects changes in emergency personnel exposure controls, frequency of emergency drills and exercises, and a title change in a local county agency. This revision, which has been reviewed by the Plant Safety Review Committee, does not decrease the effectiveness of the Radiation Emergency Plan to meet the standards of 10CFR50.47(b) and Appendix E.
