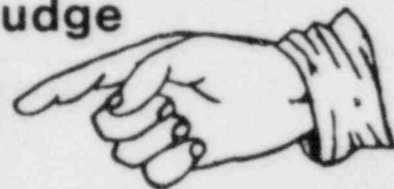

These hearings are being held to consider your comments on whether Emergency Evacuation Plans are "Adequate" and whether they will work to protect the citizens in the event of a Nuclear Accident at Limerick.

Federal Law prohibits the issuance of a Full Power Operating License for Limerick until the N.R.C. has determined that there is "reasonable assurance" that workable evacuation plans are in place.
