On October 21, 1984, while the plant was at 10% reactor power, a reactor trip occurred during a turbine generator overspeed test. The event was caused when the operator used the wrong gauge during the test. The turbine trip occurred which subsequently led to a reactor trip. The plant was stabilized at Hot Shutdown conditions, and there were no safety consequences.

At the conclusion of a refueling-maintenance outage the plant was in the process of resuming full power operation. While at 10% reactor power a Turbine Generator Trip Test was in progress to demonstrate operability of the trips.

The procedure requires a check of various parameters during each test before test handles are released from the test position, so that an actual trip does not take place. For the overspeed test, the oil pressure to the turbine stop valves was to be checked to assure restoration to the original pre-test value before the test handle was repositioned. The operator inadvertently checked a gauge located in the isolated portion of the system, not included in the test. Thinking that the pressure had been restored, he repositioned the test handle; however, the oil pressure to the stop valves (auto-stop oil) had not been returned to its pre-test value and a turbine trip occurred, followed by a reactor trip. This event and its cause has been discussed with the operators involved. In addition, the test gauge has been relabeled to more accurately describe its function.

The plant was stabilized at Hot Shutdown conditions with no safety consequences.


