Dear Mr. Denton:

The Cleveland Electric Illuminating Company, acting on its own behalf and as agent for Toledo Edison, Ohio Edison, Duquesne Light, and Pennsylvania Power is filing herewith three originals plus 60 copies of Amendment 18 to the Final Safety Analysis Report (FSAR) for the Perry Nuclear Power Plant, Units 1 and 2.

This Amendment revises Site Characteristics (Chapter 2), Engineered Safety Features (Chapter 6), Instrumentation and Controls Systems (Chapter 7), Conduct of Operations (Chapter 13) and Quality Assurance (Chapter 17), based on the results of our ongoing FSAR review program. Additional changes were made to: Design of Structures, Components, Equipment and Systems (Chapter 3), Reactor Coolant System and Connected Systems (Chapter 5), Electric Power (Chapter 8) and other miscellaneous changes.

This Amendment is in a format designed to keep current the license application and FSAR. Please insert the revised Amendment 18 material dated April 10, 1985, into the Final Safety Analysis Report as per the attached Amendment 18 Instruction Sheet.






