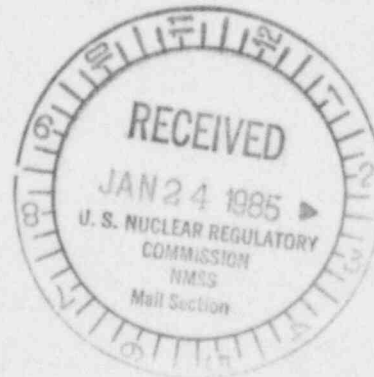

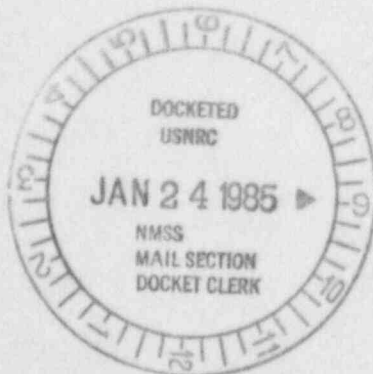

Northrop Avenue, West to Prairie Street, South to El Segundo Boulevard, West to Interstate 405, North to Interstate 10, East to Interstate 15, North to Interstate 40, east thru Arizona, New Mexico, Texas Pan Handle, to Oklahoma City, North on Interstate 35, around Wichita on Interstate 235, continue North on Interstate 135, North to Salina, East on Interstate 70 to Grandview Plaza, North on Kansas State 18 to Kansas State 113, North to Kimball Avenue turn off, East to Denison Avenue, South on Claflin Road to University Campus, to Ward Hall, Nuclear Engineering Department.

Leave Kansas State University, North on Claflin Road, West to Denison Avenue, South to Kimball Avenue to Kansas 113, South on Kansas State 18, East on Interstate 70, thru Missouri to Effingham, Illinois, North on Interstate 57 thru Champaign to Wilber Heights, East on Interstate 74 to Urbana, turn off Lincoln Avenue, right, South to Green Street, right to between Loomis Paysis Laboratory and Daniel Laboratory, right into Parking Lot, Reactor Bldg. at left, grey concrete block building.
