Subject: License Amendment Application to Delete Figures in Technical  
Specification 5.1, Design Features - Site

General:

Enclosed is an application for an amendment to the Davis-Besse Nuclear Power Station (DBNPS), Unit Number 1, Operating License Number NPF-3, Appendix A Technical Specifications (TS). As a result of comments provided by Nuclear Regulatory Commission (NRC) inspectors during the January 1991 radwaste inspection (50-346/91003 (DBNPS) dated February 25, 1991) (Toledo Edison Log 1-244), this application requests deletion of TS Figure 5.1-1, DBNPS Exclusion Area, TS Figure 5.1-2, DBNPS Low Population Zone, TS Figure 5.1-3, DBNPS Unrestricted Area Boundary for Liquid Effluents, and TS Figure 5.1-4, DBNPS Unrestricted Area Boundary for Gaseous Effluents. These TS figures are proposed for deletion on the basis that information provided by these figures is already located in the DBNPS Updated Safety Analysis Report (USAR). Additionally, TS 5.1.1, Site Exclusion Area, TS 5.1.2, Low Population Zone, and TS 5.1.3, Site Boundary, are proposed for revision to reflect the above deletions, while maintaining TS requirements addressing these site parameters. The criteria for establishing the site boundary, unrestricted area, exclusion area, and the low population zone are also defined by NRC regulations in 10 CFR Part 100, Reactor Site Criteria.

Toledo Edison requests that the NRC approve this amendment application by March 15, 1993.
