3/4.4 - REACTOR COOLANT SYSTEM

Union Electric Company herewith transmits an application for amendment to Facility Operating License Number NPF-30 for Callaway Plant. This application proposes to change Technical Specification 3/4.4, "Reactor Coolant System" and associated Bases to address the installation of laser welded tube sleeves in the Callaway Plant steam generators.

The Callaway Plant On-Site Review Committee and the Nuclear Safety Review Board have reviewed and approved the amendment request. Attachments 1 through 5 provide the Technical Specification changes, Safety Evaluation, Significant Hazards Evaluation, and Environmental Consideration, respectively. We have concluded that this amendment request does not involve an unreviewed safety question as defined in 10CFR50.59, nor a significant hazard consideration as determined per 10CFR50.92. Pursuant to 10CFR51.22(b), no environmental impact statement or environmental assessment need be prepared in connection with the issuance of this amendment.


