Dear Sir:

This letter submits, in accordance with 10CFR 50.4(b)(4)(iii), four(4) controlled copies of the revised Limerick Generating Station (LGS) Physical Security Plan. The revisions are detailed in the summary of the Plan revisions.

This revision is being submitted in accordance with 10CFR 50.54(p)(2), and has been determined not to decrease the effectiveness of the LGS Physical Security Plan or Plant Security Personnel Training and Qualification Plan. The changes to the Physical Security Plan reflect changes associated with (1) The NRC Final Rule 10CFR 73, "Protection Against Malevolent Use of Vehicles at Nuclear Power Plants", dated August 1994, which amended the regulations concerning the design basis threat for radiological sabotage to include the use of a land vehicle by adversaries for transporting personnel and their hand carried equipment to the proximity of vital areas, and to include a land vehicle bomb. (2) The Protected Area Boundary relocation associated with off-loading facility renovations. (3) Clarification concerning controls of Licensee Designated Vehicles in accordance with 10CFR 73.55(d)(4).

In accordance with 10CFR 73.21, we requested that the enclosed revisions to the LGS Physical Security Plan, which contain Safeguards Information, be withheld from public disclosure and protected as described in 10CFR 73.21. This revision to the Physical Security Plan is numbered March 1996, Issue 2, Rev. 6.
