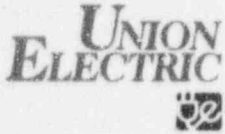

3.9.4 - CONTAINMENT BUILDING PENETRATIONS
Reference: ULNRC-3308 dated January 2, 1996

The referenced letter transmitted an application for amendment to Facility Operating License Number NPF-30 to revise Technical Specification 3.9.4 and its associated Bases to allow the containment personnel airlock doors to be open during core alterations and movement of irradiated fuel in containment.

This letter, which revises the application for amendment, is submitted as a result of discussions held on February 1 and April 1, 1996, with Ms. K. M. Thomas, NRC Project Manager. Based upon these discussions, administrative controls associated with the open status of containment during core alterations and fuel handling will be added to Technical Specification 3.9.4.

Attached is the marked-up and revised page for Technical Specification 3.9.4. We have concluded that this revision does not affect the discussions or conclusions of the original Safety Evaluation, No Significant Hazards Consideration, or the Environmental Impact Determination provided by the referenced letter.


