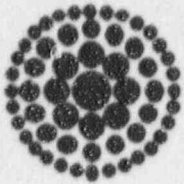

Dear Sir:

In Reference 1, Florida Power Corporation (FPC) transmitted Revision 6-9 of the Crystal River Physical Security Plan (PSP) to the U.S. Nuclear Regulatory Commission. Reference 2 documents the NRC-initiated telephone conversation between Mr. J.P. Jaudon, Deputy Director, Division of Reactor Safety, and Mr. G.L. Boldt, FPC Vice President Nuclear Production. In this telephone conversation, the NRC mandated immediate cessation of the compensatory actions specified in Revision 6-9 of the Crystal River PSP. This letter documents our immediate cessation of the compensatory actions specified in Revision 6-9 of the Crystal River PSP.

Attachment 1 to this letter provides additional information concerning FPC actions taken following the telephone conversation between FPC and the NRC on March 29, 1996; the subsequent meeting held at Region II offices on April 2, 1996; and the continuation of the NRC Region II Safeguards and Security Inspection 96-02. Attachment 1 contains Safeguards Information as defined in 10 CFR 73.21 and, as such, shall be withheld from public disclosure.


