Proposed Revision to Technical Specifications  
Electrical Power Systems - Shutdown

By letters dated May 26, 1995,<sup>(1)</sup> and October 20, 1995,<sup>(2)</sup> Northeast Nuclear Energy Company (NNECO) submitted an amendment request to the NRC Staff which proposed changes to the Technical Specifications (TS) of Millstone Unit No. 2. The proposed changes would modify TS 3.8.1.1, "Electrical Power Systems, A.C. Sources, Operating," TS 3.8.1.2, "Electrical Power Systems, Shutdown," and TS 3.8.2.2, "Electrical Power Systems, A.C. Distribution - Shutdown," to provide operational flexibility as well as consistency between action statements and to eliminate certain Mode 5 and 6 surveillance requirements.

During the Staff's review of the license amendment request, the Staff requested that NNECO withdraw the exception to Surveillance Requirement 4.8.1.1.2.c.8.

The purpose of this letter is to formally withdraw that exception proposed for Surveillance Requirement 4.8.1.2.




