This refers to your license amendment request dated March 2, 2020. Please find enclosed Amendment No. 14 authorizing an increase in material possession limits and change in radiation safety officer. Your request to add locations of use and storage was not granted on account of the locations being in Agreement State jurisdiction.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. You will be periodically inspected by the NRC.
