Please find enclosed a copy of a letter dated October 27, 1992 submitted to the Georgia Department of Natural Resources, Environmental Protection Division on November 4, 1992, requesting automatic transfer of the Vogtle Electric Generating Plant (VEGP) NPDES Permit (No. GA 0026786) from Georgia Power Company to Southern Nuclear Operating Company (Southern Nuclear) upon the proposed assumption of VEGP operational responsibility by Southern Nuclear. The permit transfer has been requested in conjunction with the proposed amendments to the VEGP Operating Licenses which would change the operator of the facility from Georgia Power Company to Southern Nuclear Operating Company.

Re: Transfer of NPDES Permits for Plant Vogtle and Plant Hatch from  
Georgia Power Company to Southern Nuclear Operating Company

Dear Mr. Reheis:

Georgia Power Company ("Georgia Power") and Southern Nuclear Operating Company ("Southern Nuclear") are currently in the process of obtaining governmental and other approvals necessary to permit Southern Nuclear to operate Vogtle Electric Generating Plant ("Plant Vogtle"), located in Burke County, Georgia, and Edwin I. Hatch Nuclear Plant ("Plant Hatch"), located in Appling County, Georgia. As part of this process of obtaining the requisite approvals, Georgia Power proposes to "automatically" transfer its NPDES permits for Plant Vogtle (Permit No. GA0026786) and Plant Hatch (Permit No. GA0004120) ("NPDES Permits" or "Permits") to Southern Nuclear in accordance with the Georgia Department of Natural Resources Environmental Protection Division ("EPD") Rule 391-3-6-.06(15)(b) and the provisions of the Permits. As will be discussed in more detail below, such transfer of the NPDES Permits to Southern Nuclear would be contingent upon Georgia Power's receipt of the requisite governmental and other approvals of the proposed assumption by Southern Nuclear of the operation of Plant Vogtle and Plant Hatch. I will promptly notify you of Georgia Power's receipt of such approvals.

Your review of this requested transfer might be facilitated by some brief background information regarding the plan for Southern Nuclear to assume the responsibility for operating Plant Vogtle and Plant Hatch. Like Georgia Power, Southern Nuclear is a wholly owned subsidiary of The Southern Company. Presently, Southern Nuclear provides services in support of Georgia Power's operation of Plant Vogtle and Plant Hatch. Through a restructuring and reassignment of Georgia Power personnel into Southern Nuclear's existing organization, Southern Nuclear's role will be increased from a support function to responsibility for the entire operation of Plant Vogtle and Plant Hatch. In operating Plant Vogtle and Plant

Hatch, Southern Nuclear will act pursuant to an agreement with Georgia Power, which acts as agent for the other co-owners of the nuclear plants (Oglethorpe Power Corporation, Municipal Electric Authority of Georgia and City of Dalton, Georgia). Southern Nuclear will have no ownership interest in the nuclear plants, and the co-owners will continue to be the owners of Plant Vogtle and Plant Hatch. To implement this plan, Georgia Power must obtain Nuclear Regulatory Commission ("NRC") approval of the proposed amendments to the facility operating licenses for Plant Vogtle and Plant Hatch authorizing Southern Nuclear to operate the respective nuclear plants. Additionally, Georgia Power must acquire all other approvals necessary to permit Southern Nuclear to operate Plant Vogtle and Plant Hatch, such as the transfer to Southern Nuclear of environmental permits like the NPDES Permits.

Automatic transfer under Rule 391-3-6-.06(15)(b) is the appropriate mode under Chapter 391-3-6 for transferring the NPDES Permits to Southern Nuclear, because no change or proposed change in process or waste water characteristics or change or potential change in circumstances affecting the conditions or restrictions prescribed by the NPDES Permits will be attendant Southern Nuclear's assumption of the operation of the nuclear plants, and, therefore, no such changes will be attendant this requested transfer of the Permits. No change in the conditions or restrictions prescribed by the NPDES Permits is either requested or required. The only change attendant this requested transfer of the Permits will be the change in The Southern Company subsidiary holding the Permits. Georgia Power interprets Chapter 391-3-6 to permit the automatic transfer under Rule 391-3-6-.06(15)(b) without public notice and comment.


As required by Rule 391-3-6-.06(15)(b), accompanying this notification letter is an agreement executed between Georgia Power and Southern Nuclear which specifies the effective date of the transfer to Southern Nuclear of the NPDES Permits, and the rights and responsibilities arising under the Permits, and which contains an acknowledgement by the parties that Georgia Power will remain responsible for any and all permit violations occurring prior to the effective date while Southern Nuclear will become responsible for any and all permit violations occurring on or after the effective date. Since Southern Nuclear cannot commence its operation of Plant Vogtle and Plant Hatch prior to Georgia Power's receipt of the requisite NRC and other approvals, the NPDES Permits cannot be transferred to Southern Nuclear prior to the receipt of such approvals. The accompanying agreement therefore provides that the transfer of the NPDES Permits will become effective upon the later of (1) commencement by Southern Nuclear of its operation of the nuclear plants following receipt of such NRC and other approvals or (2) thirty (30) days after EPD's receipt of this letter and the accompanying agreement. Based on Rule 391-3-6-.06(15)(b)(3), it is Georgia Power's understanding that the NPDES Permits will automatically

transfer to Southern Nuclear on the appropriate above mentioned effective date provided EPD does not otherwise notify Georgia Power within the thirty (30) day period following EPD's receipt of this letter and accompanying agreement.

# AGREEMENT FOR TRANSFER OF NPDES PERMITS

This Agreement is entered into this 26 day of October, 1992 by and between Georgia Power Company and Southern Nuclear Operating Company in order to facilitate the transfer from Georgia Power to Southern Nuclear of the State of Georgia Department of Natural Resources Environmental Protection Division ("EPD") NPDES Permits for Vogtle Electric Generating Plant (Permit No. GA0026786) and Edwin I. Hatch Nuclear Plant (Permit No. GA0004120) ("NPDES Permits" or "Permits"). The parties shall submit this Agreement to the Director of EPD in compliance with the automatic transfer provisions of EPD Rule 391-3-6-.06(15)(b).

Such transfer of the NPDES Permits is contingent upon the parties' receipt of all necessary Nuclear Regulatory Commission ("NRC") and other approvals of the proposed assumption by Southern Nuclear of the operation of Vogtle Electric Generating Plant and Edwin I. Hatch Nuclear Plant. Such transfer of the NPDES Permits shall become effective upon the later of (1) Southern Nuclear's commencement of operation of the nuclear plants following receipt of the requisite NRC and other approvals or (2) thirty (30) days after EPD's receipt of this Agreement and the accompanying permit transfer notice letter in compliance with EPD Rule 391-3-6-.06(15)(b); provided EPD does not otherwise notify Georgia Power within the thirty (30) day period following EPD's receipt of this Agreement and accompanying notice letter.

Upon the effective transfer of the NPDES Permits, Georgia Power shall relinquish to Southern Nuclear the NPDES Permits, and all rights and authorities arising under the Permits. Georgia Power acknowledges that, prior to the effective transfer of the NPDES Permits, it shall be responsible for ensuring that Vogtle Electric Generating Plant and Edwin I. Hatch Nuclear Plant operate in accordance with the respective NPDES Permits and all

conditions therein, and Georgia Power further acknowledges that it shall be liable for any and all violations of the NPDES Permits occurring prior to the effective transfer of the Permits. Upon the effective transfer of the NPDES Permits, Southern Nuclear shall be responsible for ensuring that Vogtle Electric Generating Plant and Edwin I. Hatch Nuclear Plant operate in accordance with the respective NPDES Permits and all conditions therein. Southern Nuclear acknowledges that it shall be liable for any and all violations of the NPDES Permits which occur on or after the effective transfer of the Permits.

The parties hereto have entered into this Agreement as evidenced below by the signatures of their duly authorized representatives.
