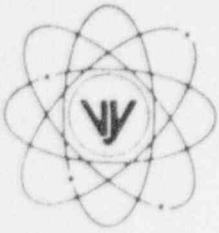

SUMMARY OF OPERATING EXPERIENCES

Highlights

Vermont Yankee operated at 99.4% of rated thermal power for the month. Gross electrical generation was 402,419 MWh or 99.1% design electrical capacity.

Operating Summary

The following is a chronological description of plant operations including other pertinent items of interest for the month:

At the beginning of the reporting period the plant was operating at 99.9% of rated thermal power.

There were no items of interest to report this month.

At the end of the reporting period the plant was operating at 97.3% of rated thermal power, and coasting down to the end of the cycle.
