THE FOLLOWING ORGANIZATION CHANGES ARE EFFECTIVE IMMEDIATELY AS PART OF ACTIONS TO INCREASE THE EFFICIENCY OF ENERGY SUPPLY AND ASSIMILATE CERTAIN PORTIONS OF THE PROJECTS, ENGINEERING AND CONSTRUCTION ORGANIZATION.

ALL GAS OPERATIONS NOW IN ENERGY SUPPLY AND PROJECTS, ENGINEERING AND CONSTRUCTION WILL BE CONSOLIDATED WITH FUEL SUPPLY TO FORM A MORE COHESIVE OPERATION FOR THE GAS BUSINESS UNDER R J ODLEVAK. DEPARTMENTS REPORTING DIRECTLY TO MR ODLEVAK WILL BE GAS PRODUCTION AND TRANSMISSION UNDER W W STILLE AND GAS PRODUCTION AND TRANSMISSION, ENGINEERING AND CONSTRUCTION UNDER J F HOLWERDA. THE GAS CONTROL DEPARTMENT UNDER M L GERTZ AND GAS PRODUCTION AND TRANSMISSION PLANNING UNDER C E SWENSON WILL REPORT TO J R BIEK, DIRECTOR OF GAS SUPPLY. THE REMAINDER OF THE FUEL SUPPLY AND MARYSVILLE ORGANIZATION WILL REMAIN UNCHANGED.

FOSSIL AND HYDRO GENERATING PLANTS WILL BE THE RESPONSIBILITY OF G L HEINS. ALSO REPORTING TO HIM WILL BE POWER RESOURCES AND SYSTEM PLANNING AND ELECTRIC DISPATCH. THOSE REPORTING TO MR HEINS WILL INCLUDE: R C HOFFMAN, J M SIMPSON, R F PIERCE, K E SPENCER, E H KAISER, C V WAITS, AND A P WURMLINGER.

A NEW ORGANIZATION, ENERGY SUPPLY SERVICES, HAS BEEN FORMED UNDER THE DIRECTION OF C R BILBY. FUNCTIONS REPORTING TO MR BILBY WILL INCLUDE MAINTENANCE AND ADMINISTRATIVE SERVICES, OPERATING SERVICES, FIELD MAINTENANCE SERVICES, STEAM HEATING, PLANT MODIFICATIONS AND MISCELLANEOUS PROJECTS, SYSTEM PROTECTION AND LABORATORY SERVICES, LAND AND RIGHT OF WAY, FACILITIES PLANNING AND RESEARCH, ENVIRONMENTAL SERVICES, AND FOSSIL AND NUCLEAR SKILLS TRAINING (INCLUDING THE NUCLEAR TRAINING CENTER).
