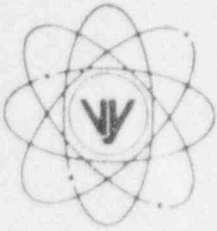

SUMMARY OF OPERATING EXPERIENCES

Highlights

Vermont Yankee operated at 92.2% of rated thermal power for the month. Gross electrical generation was 364,197 MWh or 89.7% design electrical capacity.

Operating Summary

The following is a chronological description of plant operations including other pertinent items of interest for the month:

At the beginning of the reporting period the plant was operating at 97.1% of rated thermal power.

There were no items of interest to report this month.

At the end of the reporting period the plant was operating at 87.2% of rated thermal power, and coasting down to the end of the cycle.
