Pursuant to 10 C.F.R. § 30.34(h), certain subsidiaries of Murray Energy Holdings Co. that either (1) are specific nuclear-materials licensees, or (2) possess generally licensed devices subject to the registration requirements of 10 C.F.R. § 31.5(c) (jointly, the “Murray Licensees”) hereby provide notice that they filed a voluntary petition for relief pursuant to Chapter 11 of the U.S. Bankruptcy Code on October 29, 2019, in the U.S. Bankruptcy Court for the Southern District of Ohio, Western Division, jointly administered under Case No. 19-56885 (JEH).


