**Request for Transfer of Control from ABB Inc. to JRGO, LLC for NRC License 04-24888-01**

Dear Mr. Tran,

This letter is to request U.S. Nuclear Regulatory Commission ("NRC") consent for Transfer of Control from ABB Inc. to JRGO, LLC with a corporate headquarter address located at 429 N. McEwan Street, Clare MI 48617 for NRC Materials License 04-24888-01 ("NRC license"). The anticipated closing date of the sale is May 31, 2020. The following information is provided in accordance with NUREG-1556 Volume 15, Rev. 1 Appendix E to facilitate transfer of the NRC license.

The Licensee address will remain 15411 Vantage Parkway West, Suite 200, Houston, TX 77032 ("site"). Del Davenport will remain as the Radiation Safety Officer ("RSO") for this NRC license post-completion of the transaction.

1. Subject to consent from the NRC, ABB Inc. ("transferor") plans to complete the sale of its inspection services business to JRGO, LLC ("transferee") on May 31, 2020. The site address and contact information for the NRC license will remain the same. The new Licensee name will be JRGO, LLC. As the entire business is being sold to the transferee, there will be a change in Corporate Officers. The Corporate Officers of the transferee are: John Giese, CEO and R. Keith Halley, CFO, Secretary and Treasurer. The transaction type is a transfer of assets to the transferee. The transferee will provide proof of sale of the business after completion of the transaction.
2. This ownership change will not affect the administration of the NRC license program. The RSO and authorized users will remain the same.
3. There are no planned changes in the use, possession, location, storage of the licensed materials, or any of the procedures that relate to the NRC license program.
4. **The transferor is not aware of any contamination at the licensed site and no decontamination is necessary. The site is operating in compliance with the NRC license program.**
5. **The Licensee does not have a decommissioning funding plan. This section is not applicable.**

6. The transferor confirms that all records will be transferred to the transferee at the time of completion of the sale. All surveillance items and records will be maintained and kept current by the RSO in accordance with the regulations.
7. The transferor and transferee confirm and agree to transferring control of the licensed material and activity, and the conditions of the transfer. Regarding any open inspection items, etc., the transferor commits to close out any open inspection items with the NRC before license transfer.
8. The transferee has been informed that the NRC license program will be periodically inspected by the NRC and is aware of the constraints, conditions, requirements, representations and commitments of the transferor. The transferee confirms and agrees to abide by all commitments and representations previously made by the Transferor.
9. The site is not a fuel-cycle operation. This section is not applicable.

JRGO, LLC hereby accepts the responsibility of this license No. 04-24888-01. The transferor and transferee agree to the Transfer of Control of the NRC license upon completion of the transaction.
