SUBJECT: RESPONSE TO NRC INSPECTION REPORT NO. 030-28641/92-03
(NOTICE OF VIOLATION)

Thank you for your letter of October 5, 1992, in response to our letter and attached Notice of Violation both dated September 3, 1992, regarding the inspection of Eglin Air Force Base by a member of our staff assigned to our Region II Office in Atlanta, Georgia. We have reviewed the reply, as well as your letter of October 23, 1992, in response to our phone inquiry on October 21, 1992.

We accept your explanation regarding the occurrence of Violation A.2 in the Notice in the one instance stated. This violation related to the leak testing of sealed sources at 6-month intervals. Cited were two intervals exceeding 6 months where sealed sources were not tested: January through September 1989 and April 1991 through January 1992. After review of your explanation for the January through September 1989 interval, we rescind that part of the citation; however, the violation remains valid due to your admission for the other interval where the violation had occurred.

Otherwise, we have reviewed your replies and find them responsive to the concerns raised in our Notice of Violation. We will review the implementation of your corrective actions during a future inspection to determine whether full compliance has been achieved and will be maintained.
