Gentlemen:

This is in reply to your returning Invoice No. AM01365-92 concerning License No. 29-12417-01. The copy of your September 3, 1992, letter that you sent us is addressed to the State of New Jersey.

As stated in the final revision to the Commission's fee regulations in 10 CFR 170 and 10 CFR 171 for FY 1992, which was published in the Federal Register July 23, 1992, the Commission exempted from the FY 1992 annual fee those licensees and holders of certificates, registrations and approvals who either filed for termination or for a possession only/storage license during the period October 1, 1991, through December 31, 1991.

Because you did not file a request to terminate License No. 29-12417-01, it is an active license for billing purposes for FY 1992. Accordingly, Invoice AM01365-92 is past due and payable. Please be aware that interest, administrative and penalty charges have been assessed on this delinquent debt. This delinquent debt now totals \$4827.64 through October 24, 1992. Non-payment of debts due the NRC may result in suspension or revocation of any other license or approval issued to the licensee and referral of the delinquent debt to a collection agency in accordance with 10 CFR 15 of the Commission's debt collection regulations, copy enclosed.

Enclosed is Form 526. If you determine you meet NRC's small business size standards, please complete the form. A reduced fee of either \$1800 or \$400, with applicable charges, would then be due. If you wish to terminate your license, please notify NRC's Region I office located in King of Prussia, Pennsylvania.


